### What is LEDES and How Does it Work?

LEDES stands for Legal Electronic Data Exchange Standard. In 1995, a non-profit organization called Legal Electronic Data Exchange Standard Oversight Committee was established to develop legal billing standards that would "meet the needs of corporations, law firms, and legal industry software vendors." They sought to keep bills simple and unambiguous, without the extraneous information that attorneys often add to their invoices.

There are five basic principles to LEDES billing, including:

- 1. A simple billing process simple
- 2. Reduce questions and confusion about bills
- 3. Minimal deviation from existing legal billing formats
- 4. A billing system where law firms can utilize their existing financial systems
- 5. Meeting the needs of law firms and corporations working within the legal industry

The billing formats created by the LEDES Oversight Committee are now widely used across the domestic and international legal communities.

#### Which Practice Areas Work Best with LEDES

LEDES billing is commonly used by attorneys who work in personal injury law, like bodily injury and property damage cases, workers' compensation cases, and homeowner's insurance disputes. Attorneys in these practice areas often work with third-party clearinghouses – typically insurance companies – to secure compensation for their clients. LEDES billing uses one centralized billing format to make the process streamlined and easier to complete.

## **Issuing Invoices**

When it comes to issuing invoices, LEDES billing codes can streamline the process making the task easier for law firms to happen. LEDES codes, also referred to as, Uniform Task-Based Management System (UTBMS) codes, allow law firms to separate and compartmentalize their billable tasks and expenses. For example, LEDES timekeeper classification codes quickly categorize the various levels of timekeepers that may work on a matter, from law firm partners to legal assistants.

LEDES also provides defined Activity Codes based on common tasks undertaken by law firms. By implementing LEDES billing, law firms can quickly choose the most appropriate activity code instead of constantly reinventing their own to define tasks completed on a matter.
